

Allocation to Areas of Practice

The following table is designed to give further guidance on the allocation of fee receipts to areas of practice. The guidelines for the areas of practice are not intended to be exclusive (and so they include but are not limited to the list), nor will the allocation in the table always be appropriate for every individual case which falls within the general description in the right-hand column. The appropriate test is the underlying subject matter of the work from which the income is derived. This means that fee income should normally be allocated in accordance with the predominant or core nature of the dispute or matter from which the income is derived. The court or other forum for proceedings is not determinative, although this may assist in identifying the appropriate allocation.

For example, an action in the Technology and Construction Court which involves an action for damages against a developer to which an architect is joined should be classified by all involved as Construction, even though allegations of professional negligence are made against the architect. Similarly, an action in the Commercial Court which involves a claim for indemnity against insurers and a contingent claim against the insurance broker should be classified by all counsel as Commercial and Financial Services. By contrast, if the action is solely against the architect or the insurance broker, the core nature of the claim will be professional negligence. In those circumstances, all income should be classified as professional negligence.
